We expressly exclude and damage going beyond the same, in particular consequential damage form defects such as loss of profit, expenses for de-installation and re-installation etc.

Following a number of tests determining colour fastness conforming to EN438-2.29, a minimum value of 4 on the five-part grey scale conforming to EN20105-A02 is to be tolerated.

LEMINEX shall warranty only for such panels as have not suffered damage on account of wrong or careless storage, machining, application, or handling.

LEMINEX shall expressly not be liable for defective sub constructions or installation as these are outside our influence.

Machining and installation must conform to the Technical Information Brochures of LEMINEX.
